You may extend the interval during periods of low activity, but you must take adequate preservation precautions.

*The time specified is the time required to perform all services at the particular interval.

Clean fittings before lubricating. Lubricate points indicated by dotted arrow

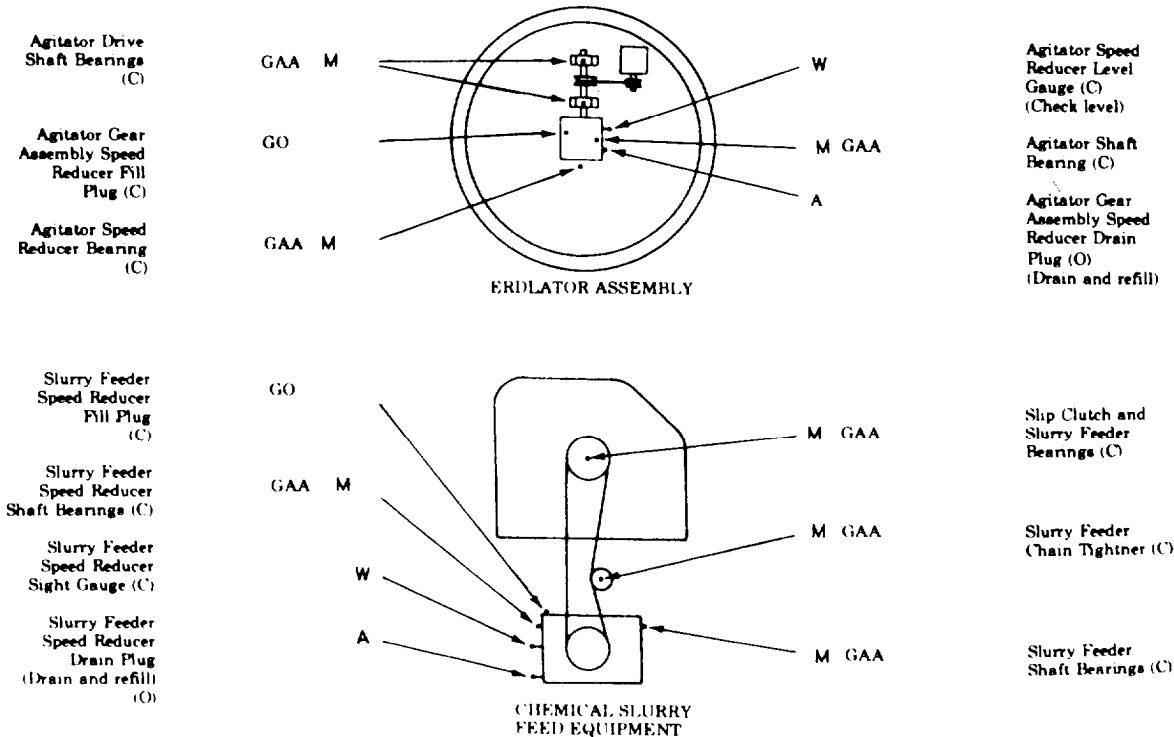
shaft on both sides of equipment. Clean parts with drycleaning SOLVENT (SD), type II or equivalent. Dry before lubricating. Drain gear case when HOT. Fill and check level. The lowest level of maintenance authorized to lubricate a point is indicated by one of the following: (C) Operator/Crew, or (O) Organizational Maintenance.

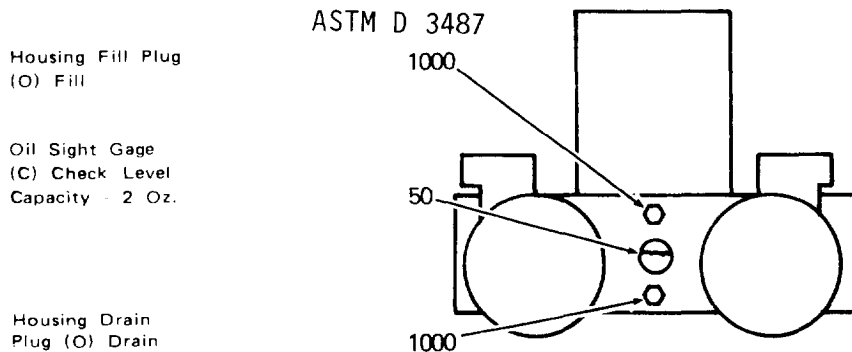
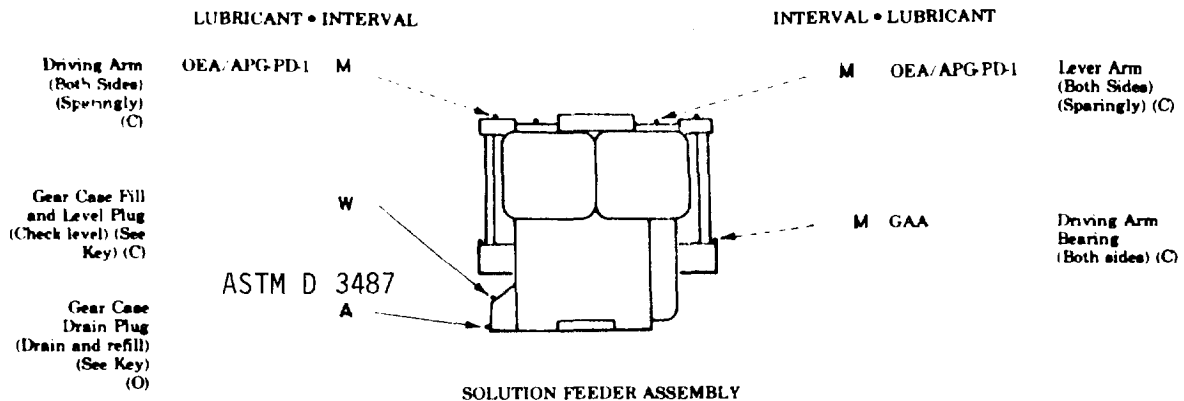

2. OIL CAN POINTS. Every 50 hours clean and lightly coat all door hinges, latches and cables with OEA/APG-PD-1.
